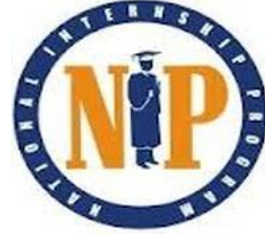

FOR PRIME MINISTER'S YOUTH TRAINING SCHEME
HIRING OF THIRD PARTY EVALUATION FIRM/CONSULTANTS

National Internship Program is an apex body designed to provide basis for youth training and development. The project 'Prime Minister's Youth Training Scheme, 2015-18, has been designed for the benefit of fresh and unemployed educated youth of Pakistan who have completed either 16 years of education or matric with diploma from government recognized institutions in different subjects. The training scheme is for one year. Approximately 50,000 interns were included under Phase-I of the scheme and about 35,000 interns has been placed in Phase-II and 15,000 more will be hired soon in Phase-II.

NIP invites eligible and interested individual consultancy firms, universities and research organizations having specialization in monitoring and evaluation (M&E) of different programs for evaluation of PMYTS (Prime Minister's Youth Training Scheme). Responding firms may provide verifiable information indicating that they are qualified to perform the evaluation of the program. The interested firms/organization who meet the below mentioned eligibility criteria are invited to submit their expression of interest including technical and financial proposals.

ELIGIBILITY CRITERIA

- Be registered under any governing law.
- Not be blacklisted by SECP, PPRA or any other governing body
- Have 03 to 05 years of relevant experience in the field of baseline, assessments and evaluations for public, private, donor funded and service programs.
- Preference shall be given to those, having work experience with International donors like UN, ADB, DFID, WB, and USAID etc for a minimum of 05 years.
- Be based in Islamabad, presence in the Provincial Capital and should have outreach in far flung areas of Pakistan.
- Have sound management capabilities.
- Preferable should have an average annual turnover in excess of rupees 50 Million (for the past three years).
- Should have documentary evidence of income tax paid during the last three financial years.
- Must have Sales Tax Certificate.

The firms meeting the eligibility criteria can send the expression of interest along with company profile and documents supporting firm's eligibility as per RFP to below mentioned address not later than 1100 hrs on 26 April, 2018.
